Building Code Permits Fees:

Fees for permits pursuant to this Section shall be based on the types of inspections required. This value will be based on current costs of construction as determined by the Building Inspector.

Administrative Fee \$25 per permit application

Plan Review Fee \$50 per permit application

One & Two Family Homes \$850 + \$.12 per square foot (square foot total is based on all finished space, unfinished space and attached structures that are part of the submitted plan such as an attached garage, deck or porch).

Manufactured Homes To be placed upon a permanent basement foundation, slab or piers. \$600 flat fee plus \$.12 per sq. ft.

Additions & Alterations Any building cost (additions or alterations) under \$100,000 will be charged as follows: one-two family dwellings - \$65 per inspection type; commercial - \$140 per inspection type* (**Inspection types listed below*).

Any building cost (additions or alterations) over \$100,000 will be considered new construction and will be charged accordingly. Building cost per to RS Means costs. (*See “One & Two Family Homes” above and “Commercial & Industrial” below*).

Commercial & Industrial \$950 + \$.25 per square foot on the first 10,000 square feet of finished space and \$.10 per square foot on any remaining finished space, all unfinished space and all attached structures that are part of the submitted plan such as an attached garage, deck or porch.

Footing & Foundation Permit \$250. To continue beyond footing/foundation, the fee scheduled for inspection and plan review of new construction will be charged.

Renewal Fee Half the original permit fee (minimum \$50; maximum \$250)

Re-Inspection Fee	\$100.00 per extra inspection in excess of the number of required inspections per Wisconsin Administrative Code SPS 320.10 (3). An inspection is viewing media, a site visit, and/or reviewing data submitted by external sources (such as qualified engineers) to determine compliance. Additionally, a \$110.00 fee will be assessed if the project is not ready for the scheduled inspection, failure to cancel inspection at least one hour prior to scheduled time, storage or personal items blocking necessary inspection areas, multiple inspection failures, and/or no access to site and/or building.
Move or Raze	\$85
Minor repairs and alterations costing less than \$2,000.00, which do not change occupancy, area, structural strength, fire protection, exits, natural light or ventilation	No Charge or Permit Required
Repair or replacement of an external roof surface, including without limitation: shingles, metal roofing, tiles or rubber membrane. Any structural repair to a roof or replacement of trusses or sheeting requires building permit.	No Charge or Permit Required
